NRI/PIO/OCI/Foreigners - Document Verification Schedule

for admission to Medical Courses to the candidates who have qualified in NEET-2017.

Pursuant to the directions of the Hon'ble High Court in WP. 23448 / 2017, Government has directed KEA to conduct document verification for NRI / PIO / OCI / Foreign Nationals.

"15% of the total intake in Medical colleges shall be filled up from students who are NRIs which includes NRI's Children or their Wards; OCIs, PIOs and Foreigners. These students will not be eligible for admission to any other category of seats".

Further, as per the Government letter No. HFW(ME)/320/ACS/2017 dated 18.07.2017, KEA will be conducting counseling only for medical courses pertaining to the 15% of NRI/OCI/PIO/foreigners' quota of seats as notified by the Government. The counseling for Dental courses for the NRI/OCI/PIO/foreigners will not be conducted by KEA.

The document verification for the eligible NRI / PIO / OCI / foreigners will be conducted on **21-07-2017 from 10.00 am** onwards. All eligible candidates have to attend document verification based on their NEET All India Rank in Bangalore Helpline Centre with all the necessary original documents.

NOTE:

- 1. Those who have already applied for NRI through online registration are eligible for NRI quota seats. NRI/PIO/OCI/foreigners who have not applied so far for the above quota can register through online afresh and walk-in for the document verification with all the relevant original documents on 21.07.2017.
- 2. The candidates who have got verified under CET-2006 admission rules can appear for NRI quota if they fulfill required eligibility conditions. They have to compulsorily appear for NRI document verification with all the necessary required documents.
- 3. Any other candidates who are Citizen of India otherwise eligible to get seats in Karnataka are also eligible if they fulfill the required eligibility conditions.
- 4. If any candidate have already verified for NEET in KEA, have to submit necessary documents other than the already submitted documents as prescribed for NRI/PIO/OCI.
- 5. Foreigners will be considered as per the directions and orders issued by the Government.
- 6. Foreigners will have to produce the eligibility certificate issued by the Rajiv Gandhi University of Health Sciences, Bangalore to KEA at the time of document verification. They can also submit the equivalence certificate issued by the Association of Indian Universities, Delhi at the time of document verification ie., on 21.07.2017.
- The foreigners can submit all the necessary documents as prescribed in the brochure and in the Notification by
 e-mail to <u>keauthority-ka@nic.in</u> or they can come in person for the document verification to KEA on
 21.07.2017.
- 8. Admission to foreigners is purely provisional subject to fulfillment of any other requirements issued by the Government /Universities.
- 9. Refer e-brochure UG-NEET-2017 and KEA website (www.kea.kar.nic.in) for documents to be produced.
- 10. All NRI/PIO/OCI candidates have to compulsorily appear for the NRI/PIO/OCI document verification with all the necessary required original documents to KEA, Bangalore.
- 11. The admission / allotment of medical seats is subject to the eligibility criteria and approval by the competent authority.

N.B.: No individual intimation will be sent to the candidates regarding the above schedule.

The following ORIGINAL DOCUMENTS AND ONE SET OF ATTESTED PHOTOCOPIES have to arrange IN THE SEQUENTIAL ORDER SHOWN BELOW AND PRODUCE THE SAME IN THE VERIFICATION COUNTER FOR verification of documents.

- a. The final print out of the Online Registration Form.
- b. Original Copy of the Chalan for having paid the fees.
- c. 'NEET 2017' Admission Ticket
- d. Any valid Identity Card (Driving Licence / Voter ID / Passport / PAN / Aadhar Card)
- e. SSLC / 10th Standard Marks Card
- f. 2nd PUC / 12th Standard Marks Card
- g. 2nd PU /12th standard Study Certificate issued by concerned college with seal signature of Principal
- h. TWO recent passport size photographs
- i. Candidate's parents resident certificate issued by the Embassy of that country complying with the Income Tax Rules / any other certificates to establish evidence that they are resident of that country / affidavit on Rs.100/- e-stamp paper to that effect.
- j. Candidate's passport / VISA / Resident VISA.
- k. Citizenship of the candidate.
- l. Income Tax Documents required as per the Income Tax Act 1961.
- m. Candidate's study certificate for having studied outside India where applicable for the qualifying examination.
- n. Along with Ward Certificate Annexed.

The foreigners in addition to the above documents, will have to produce the eligibility certificate issued by the Rajiv Gandhi University of Health Sciences or the equivalence certificate issued by the Association of Indian Universities, Delhi at the time of document verification ie., on 21.07.2017 in KEA, Bangalore.
